

## Overview

GCP Infrastructure Investments Limited (the "Company") is a Jersey-incorporated, closed ended investment company whose shares are traded on the main market of the London Stock Exchange. The Company's investment strategy is to provide shareholders with long term distributions by generating exposure to debt issued by UK infrastructure project companies and related or similar assets.

The Company primarily targets investments in completed infrastructure projects with long term, public sector-backed, availability-based revenues. The Company is permitted to invest up to 25% of its net assets in investments which do not meet these criteria. Where possible, investments are structured to benefit from partial inflation-protection.

# Company update

As at 30 October 2015, the Company was exposed to a portfolio of 40 infrastructure loans valued at £655.1m. The principal value of the loans is £600.3m with an annualised yield of 9.0% and an average life across the portfolio of 13 years.

On 1 October 2015, the Company announced the appointment of Michael Gray and Julia Chapman as non-executive Directors of the Company with effect from 1 October 2015.

On 1 October 2015, The Company also announced it had given its consent for the Investment Adviser to act as the investment manager of Project Finance Investments Limited, on the basis that the Investment Adviser identifies an investment which falls within the Company's remit, the Company will have a right of first refusal.

On 13 October 2015, the Company announced a dividend of 1.9 pence per ordinary share, for the period from 1 July 2015 to 30 September 2015. The dividend will be paid on 25 November 2015 to holders of ordinary shares recorded on the register as at the close of business on 23 October 2015.


