



GCP INFRASTRUCTURE INVESTMENTS LIMITED AIFMD Remuneration Disclosure

With effect from 22 July 2014, the Company's Investment Adviser was authorised as an AIFM by the FCA under the AIFMD regulations. The Company has provided disclosures incorporating the requirements of the AIFMD regulations, which are available on the Company's website <https://www.graviscapital.com/regulatory>

All authorised AIFMs are required to comply with the AIFMD Remuneration Code. Under article 22(2) of the Directive the Company's Investment Adviser must disclose the remuneration of its staff, including senior management, risk takers, control functions.

The total amount of remuneration for the period from 1 October 2017 to 30 September 2018, split into fixed and variable remuneration, paid by the AIFM to its staff is as follows:
